1. The Competition will be carried out in accordance with the rules and regulations of the FARS
2. Drug testing may take place at this or any other event held by the FARS or held under their rules skaters must agree to drug tests whenever required.
3. Arrange for FARS office (via the official FARS Calculator for the event) to receive programme of events and results showing the marks, place marks and a summary of the marks of all those taking part in the Competition also the names of all officials i.e. Judges and Referee for each Competition and the Calculator for the event.
4. Details of 1) and 2) above will be stated in the programme and on all other notices issued relative to the Competition.
5. It is the responsibility of the Club applying for the permit to ensure that all competitors are members of FARS. If, after the event has taken place, any competitors are found not to be current members of FARS then the applicant Club WILL be held responsible for the FULL subscription/s (£20.00 for Juniors or £29.50 for Seniors) of those non members.
6. Clubs should ensure that their Competition entry forms include a column for the entry of membership numbers. Further, they should remind skaters that they should carry their membership cards with them as they may be asked to show them to prove age or membership.
7. LINE FEES For all competitions a levy of 75p is payable on each entry line from the published results. This applies to both affiliated and non-affiliated clubs. If these are not paid within 28 days after the Competition double fees will be invoiced.
